B. About the lessons and the recording system

Lessons are delivered by a certified driving instructor in a vehicle provided by CC Driving Instruction, with the instructor accompanying the participant at all times. The vehicle is equipped with the ClearConnect in-vehicle system: cameras and sensors that record video, audio, and driving telemetry (such as speed, position, and motion) during the lesson. Recordings are analyzed to produce a scored lesson report, short video clips of key moments, and a personalized practice plan (together, "My Lesson Review").

C. Recording & data consent

I consent to the following on behalf of the participant named above:

- Video, audio, and driving telemetry of the participant may be recorded during lessons.
- Recordings are stored securely. Video clips are retained for approximately 30 days after delivery and are then automatically deleted.
- Lesson reports and links to video clips are delivered by email to the parent/guardian email address given above.
- Recordings and reports are never sold, never posted publicly, and are not shared with third parties.
- I may withdraw this consent for future lessons at any time by writing to rico@ccdrvn.com.

D. Assumption of risk & release

I understand that driver training takes place in real traffic and, like all driving, carries inherent risks that cannot be eliminated even with careful instruction, including the risk of collision, injury, and damage to property. I confirm the participant holds a valid Ontario G1 or G2 licence and will follow the instructor's directions during lessons.

In consideration of the participant being permitted to take part in lessons, I release Richard Cooke, carrying on business as CC Driving Instruction, from claims, losses, or damages arising out of the ordinary negligence of the instructor in connection with the lessons. This release does not apply to gross negligence or wilful misconduct, and nothing in this document limits rights that cannot be waived under Ontario law.

E. Vehicle & incidents

Lessons take place in a vehicle provided and insured by CC Driving Instruction. I agree that any incident, collision, or damage occurring during a lesson must be reported to the instructor immediately so it can be handled through the proper insurance process.
